Each time a user accesses the Emschergenossenschaft website, and each time a file is called up, data on this process is stored in a protocol file. These data are not personal; we cannot determine what user called up what data.

- Name of the called file
- Date and time of the call
- Volume of data transferred
- Notification of whether call was successful
- Name of your Internet service provider
- Operating system and browser software of your computer, if required
- The website from which you have reached us

The IP address of the computer from which the inquiry was sent is not stored. This means that personal user profiles cannot be created. The data mentioned above is evaluated solely for statistical purposes by a service provider domiciled in Germany that has been commissioned by the Emschergenossenschaft. Personal data

is gathered only when you give it to us voluntarily, for example when registering (e.g. for the email service or the brochure ordering service) or making an online application, in a survey or contest etc. Our website does not use any cookies. Nor are other technologies used that serve to record the visitors' behaviour.

## **Use and Dissemination of Personal Data and Limitation of Use**
